The terms and conditions of regularization of the above officer(s) are as under:-


- i) That the above regularization will be treated as fresh direct appointment and will be effective from the date of joining on regular appointment. The seniority of the contract AE so regularized shall be on the basis of their merit in the selection list vide letter No.09-22/2019-PSC(R-IV)



dated 4.03.2020 & even No. 09-22/2019-PSC(R-IV) dated 4.09.2020 issued by H.P.Public Service Commission, Shimla



- ii) The post(s) of Assistant Engineer (Electrical) (Class-I Gazetted), is temporary but likely to continue.
  - iii) That on regularization, the officer(s) shall be appointed on the minimum of the time scale and fixation of pay will be done under provisions of rules and orders/instructions in force & issued from time to time.
  - iv) The officer(s) shall be on probation for a period of 02 years from the date of joining the post. The period of probation is liable to be extended at the discretion of the Appointing Authority. Failure to complete the period of probation to the satisfaction of the Competent Authority shall render them liable to be discharged from service.
  - v) The officer(s) shall have to pass the prescribed departmental examination within three years viz. six chances from the date of joining, failing which they shall not be eligible for:-
    - a) Annual increment falling due after the above period.
    - b) Confirmation to the service and
    - c) Promotion to the next higher post.
  - vi) The appointment may be terminated at any time by one month's notice given either side viz the appointee or the appointing authority. The appointing authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period by making payment of a sum equivalent to the pay and allowances for the period of notice or the un-expired period thereof.
  - vii) The officer(s) shall be liable to serve anywhere in the State of Himachal Pradesh and also outside where the HPSEBL has its offices.
  - viii) The regularization shall be subject to the verification of character and antecedents of the candidates. If anything adverse is reported against the candidates, the appointment will be treated as null and void.
  - ix) The regularization of the officer(s) shall be subject to the production of Medical Certificate of fitness from the Chief Medical Officer/Medical Board.
  - x) The officer(s) shall be required to take an oath of allegiance/faithfulness to the Constitution of India (or make the solemn affirmation to that effect) in the prescribed form and also to take oath of secrecy as required under 'official's secrets Act'.
  - xi) The Officer(s) shall be required to submit declaration in the prescribed form (in case of married) that he/she has only one living spouse. In the event of having more than one more living spouse, the appointment shall be subject to being exempted from the enforcement of the requirement in this behalf.
  - xii) No travelling allowance shall be allowed for joining the appointment/post.
  - xiii) Other condition(s) of service shall be governed by the relevant regulation/rules and orders issued by the HPSEBL from time to time.
  - xiv) The officer(s) are required to produce all original certificates in support of their academic/technical qualification, age and reserved class against which they were appointed as such.
  - xv) If any declaration given or information furnished by the officer(s) proves to be false or if found to have willfully suppressed any material, information, shall be liable for removal from service and such other action as may be deemed necessary.
  - xvi) The officer(s) shall also be required to submit the prescribed return of assets and liabilities as on in date of joining and as on 1<sup>st</sup> January of every year thereafter to the competent authority within two months of joining the service.

If, the above terms and conditions are acceptable, the above officers are directed to join their duties at their present place of postings within seven days and submit charge assumption report to this office immediately, failing which regularization shall stand cancelled and no further extension will be accorded.
