


NOTIFICATION

The Governor, Himachal Pradesh is pleased to declare 12th November, 2022 (Saturday) as a "Public Holiday" in Himachal Pradesh on account of General Election to 68 Constituencies of Himachal Pradesh Legislative Assembly (in case poll is held) to enable the employees working in all Government Offices/Boards/Corporations/ Educational Institutions and Industrial Establishments situated in Himachal Pradesh to exercise their right to franchise. This will also be a **paid holiday** to daily waged employees and also within the meaning of section 25 of Negotiable Instruments Act, 1881.

Further, it is clarified that special casual leave may be given to those employees who are working in different places in the State but have right to vote in other Constituencies/ Places in the State on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/her vote.


