Proceeding of the meeting held on dated-06.04.2022 at 11.00 AM in the conference hall of HPSEBL under the chairmanship of Executive Director (Pers.) HPSEBL to discuss a long pending issue of EPF & ESI with regard to outsource employees working in HPSEBL.

List of the participants is attached at Annexure-A


At the outset of meeting, Chairman welcomed all the participants i.e. DDO's of HPSEBL and also invite the attention towards the agenda whether EPF & ESI subscription with regard to outsource employees are being deposited by the Service provider or not.

Only 65 DDO's were presented in the meeting and detailed discussion was held with them for non-supplying of the requisite information within stipulated period. 46 DDO's have come with the requisite information which is being checked and compiled by concerned dealing hand. It is further stated that only 46 DDO's submitted the desired information and left out has committed that the same will be submitted within ten days. The DDO's (approximately 45) who have not attended the above said meeting a separate meeting will be conducted very shortly.

In the meeting, all the DDO's has raised so many grievances regarding submission of EPF & ESI with regard to outsourced employees and the same have been settled by the Chairman in the meeting. The issue regarding compassionate employment also discussed in the meeting.

After detailed deliberation, it was decided that a meeting with regard to above issue will be held very shortly with the DDO's who have not attended the meeting and further directed the DDO's to submit the requisite information within ten days positively to enable us to submit the same with EPF Commissioner at earliest.

It is also decided that CA will take necessary steps after examine this report submitted by the DDO's present in meeting. CA may be requested to complete the special audit report w.r.t non-depositing of EPF/ESI of outsourced person in their account by the service provider.
