

**WHEREAS**, Sh. Dalip Singh, Sr. Assistant vide his application dated 19.2.2022 has made a request to forego his promotion as Supdt. Gr-II due to his domestic circumstances.

**WHEREAS**, it has been laid down in appendix-29(xiv) of C.S.R-Vol-III that when an employee does not want to accept promotion which is offered to him/her may make a written request that he/she may not be promoted and the request will be considered by the appointing authority taking relevant aspects into consideration.

Gr-II for one year from the date of refusal or till next vacancy arises, whichever is later, is hereby accepted by withdrawing the benefit of promotional increments granted to him on completion of 23 years service from the date of acceptance of forfeiture for the period of one year.


