Please refer to CAO office letter No. HPSEBL/F&A/CPC/3601  
(DDUGJY) Misc/S-DA/2019-2107-2207 dated 22.01.2019 vide which it was  
directed to all the circle accounting units to maintain District-wise  
expenditure incurred against DDUGJY scheme and circle wise expenditure  
for IPDS scheme and submit detail of expenditure to Accounts  
officer(Compilation) as well as Nodal officer on monthly basis. It has been  
informed by Nodal Officer i.e. CE(SP) of these schemes that the desired  
information/data is not being submitted by concerned circles thereby  
resulting in delay in filing of claims by Nodal Officer. Due to non-  
availability of data from field offices, the Nodal Officer is not in position to  
file the reimbursement claims of these schemes and the bills of various  
suppliers amounting to Rs. 30.00 crores are pending for want of payment  
in F&A Wing. It is also added that bills are being received in this office  
directly from concerned Divisions and not from respective circles  
thereby non availability of information of bills of particular scheme.

Keeping in view of above position, all the circles/Accounting units under

your control may be directed to follow the guidelines already issued by
