Subject:- Regularisation to the post of Assistant Engineer(Electrical) in the Pay Band of Rs.16650-39100+ Rs.5800 Grade Pay.

Sir,

In continuation of this office letter No. HPSEBL(SECTT)/101-28 /2016-31839-44 dated 16.7.2016 as per notification issued vide PER (AP) C-B (2) -1/2019, dated 21.2.2019 and further notified vide this office vide notification No.HPSEBL (Sectt)/R&E/Govt. Instt. Misc.2019-96787-97067 dated 08.03.2019 to regularize the services of contract Assistant Engineers on the post of Assistant Engineer (Electrical) in the Pay Scale of Rs. 16650-39100+5800 Grade Pay, you are hereby regularized on the post of Assistant Engineer (Electrical) in the said scale with immediate effect or from the date of joining as regular Assistant Engineer (Electrical) on the following terms and conditions:-


1. You will be on probation for a period of two years. During the probation period your services can be terminated by the Board without assigning any reason thereof.
2. The post of Assistant Engineer (Electrical) Gazetted Class-I) is temporary, but is likely to continue.
3. You will have to pass the Departmental Examination for Engineering Officers within three years (Viz six chances) from the date of your joining failing which you shall not be eligible to:-
  - i) Annual increment falling due after the above period.
  - ii) Promotion to the next higher grade/rank
  - iii) Confirmation in the existing grade/rank.
4. You will be liable to serve in any part of Himachal Pradesh and also outside where the H.P. State Electricity Board Ltd has its offices.
5. The regularisation may be terminated at any time by a month's Notice given by either side viz., the appointee or the appointing authority. The appointing authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment of a sum equivalent to the pay and allowances for the period of notice of the un-expire period thereof.
6. You will be required to take an oath of allegiance/faithfulness to the Constitution of India (or make solemn affirmation to that effect in the prescribed form) and also to take oath of secrecy as required under 'officials secrets Act'.

7. You will be required to submit declaration in the prescribed form that in case you are married, you have only one living wife. In the event of having more than one wife living, the appointment will be subject to your being exempted from the enforcement of the requirement in this behalf.
8. The regularisation will be subject to your being declared Medically fit, expenses of medical examination will have to be borne by you. The medical examination may be got conducted from nearby concerned Chief Medical Officer/Medical Board.
9. The regularisation will be subject to the verification of character and Antecedents by the concerned authority.
10. No travelling allowance will be allowed for joining the appointment/post.
11. Other conditions of service will be governed by the relevant Regulations/Rules and orders issued by the Board Ltd from time to time.
12. If any declaration given or information furnished by you proves to be false or if you are found to have willfully suppressed any material information you will be liable for removal from service without notice and such other actions as may be deemed necessary.
13. You are required to submit certificate regarding scheduled Caste/ Scheduled Tribe/Backward Class Ex-servicemen and Ward of Freedom Fighter (where applicable) at the time of joining of post.
14. Your Seniority in the batch shall be determined on the basis of merit assigned by the HP Public Service Commission.
15. You will also be required to submit the prescribed return of assets and liabilities as on in date of joining and as on 1<sup>st</sup> January of every year thereafter to the competent authority within two months of joining the service.


In case, the above conditions are acceptable to you are required to report for duty as Assistant engineer (Electrical) at the present place of posting immediately.
