The inter-se-seniority of the above officers in the grade of Sr. Executive Engineer (C/M) will be fixed later on.



Both the above officers shall join their new assignment within 15 days from the date of issue of the orders, failing which their, promotion orders shall deem to have been cancelled without any notice.


In case of officers where change of station is involved usual TTA/JT will be admissible as per Rules.
