The officer/officials who have not passed the Departmental Examination prescribed for Junior Engineer(E) and other equivalent rank in HPSEBL, shall have to pass the same in six chances within three years from the date of notification of regulation for departmental examination of Junior Engineers failing which their confirmation orders are subject to cancellation. This relaxation shall continue till the Departmental Examinations are conducted by the HPSEBL.

The officer/officials who have rendered regular military services before joining the civil employment they shall opt either :-

(a) To continue to draw the military pension.

Or

(b) To refund the pension/gratuity and count the military service as qualifying service for civil pension.

(c) The option should be exercised within three months from the date of issue of this order.
