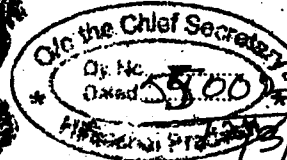

You are aware that the next decennial Population Census of India is going to be conducted in two phases. The 1<sup>st</sup> phase of Houselisting and Housing Census along with updation of National Population Register (NPR) would be conducted in a period of 45 days during April-September, 2020 in different States/UTs as per their local conditions and other priorities. The 2<sup>nd</sup> phase of Census 2021 (Population Enumeration) would be conducted from 9<sup>th</sup> to 28<sup>th</sup> February, 2021 with a Revision round from 1<sup>st</sup> to 5<sup>th</sup> March, 2021 in the entire Country except the snow-bound areas of Jammu & Kashmir, Ladakh, Himachal Pradesh and Uttarakhand, wherein it will take place during 11<sup>th</sup> - 30<sup>th</sup> September, 2020 followed by Revision round from 1<sup>st</sup> to 5<sup>th</sup> October, 2020.

2. The decennial Population Census is a gigantic task of national importance which is accomplished with the man power support of the States and Union Territories. It is needless to say that the Census provides the basic benchmark data up to the lowest administrative units, i.e. villages in rural areas and towns/wards in urban areas, required for various government policy formulations. It also caters to the Constitutional needs like delimitation and reservation of constituencies for Parliamentary, Assembly, Panchayat and other Local Bodies etc.

3. You may appreciate that the concurrent field work of any other survey or revision of electoral roll or any local level election etc. during Census field work would create a lot of confusion in the public, leading to adverse impact on quality. Since the decennial population Census is a one take exercise, it is necessary to have no other field surveys or election etc. during the period of Houselisting and Housing Census in your State/UT as well as during the period from 1<sup>st</sup> February to 5<sup>th</sup> March, 2021 for Population Enumeration.

4. I shall be grateful, if you could kindly arrange to issue suitable instructions to all concerned to avoid any other survey and election related work during the Census time schedule in your State/UT so as to make this important national task a complete success. It will be highly appreciated if a copy of the said instruction is endorsed to our office for record.
