OFFICE ORDER

Whereas, in pursuance of Show Cause Notice issued to Gian Chand, CHDM presently working in O/O SE (Design), Electrical System, HPSEBL, Hamirpur vide this office endst. No. HPSEBL/Court Case Sh. Gian Chand/2020-45843 dated 3-7-2020, Sh. Gian Chand had submitted a detailed reply on above notice which was given by him personally in this office on 17-07-2020. He was also afforded an opportunity of personal hearing in the matter on the same day. Sh. Gian Chand was apprised that representations have been received regarding wrong seniority assigned to him w.e.f. 1.11.1995 vide this office order bearing No. CEO/ED-4/7351-55 dated 4-8-2015 on the ground that representees had joined earst while HPSEB prior to his joining on daily wages basis. Sh. Gian Chand gave another written statement before undersigned (which stands duly authenticated) mentioning that he had joined on daily wages basis on 21-06-1989. The certificate in this regard issued by Sr. Executive Engineer, Electric al Division, HPSEBL, Hamirpur was also submitted by him mentioning that his initial date of engagement on daily wages basis is 21-06-1989.

Therefore, after going through the record and reply submitted by Sh. Gian Chand, the undersigned is satisfied that Sh. Gian Chand, CHDM initially joined in the HPSEBL on daily wages as on 21-06-1989. The seniority assigned in favour of Sh. Gian Chand, JDM(Now CHDM) above Sh. Mohan Singh, CHDM in the final seniority list of JDM circulated vide this office order dated 14.1.2002 as it stood on 1.1.2002 at Sr. No. 1 is not in order, as his date of initial appointment on daily wages is later than the date of engagement of S/Sh./Smt. Mohan Singh, Punam Kaushik, Vidya Shandil, Sunita Devi, Yog Raj, Bishan Dass and Satya Parkash. All the persons mentioned above have joined HPSEB prior to 21-06-1989 on daily wages basis.




