Subject:- Regarding retention of GPF accumulation with the HPSEBL after retirement.

In this context, It has been noticed that the retiring/retired officers/officials who retain his/her GPF accumulation with HPSEBL after retirement are being sent the GPF retention application to the Chief Accounts Officer, F&A Wing HPSEBL Shimla-4 directly which is a violation of the instructions /notifications issued by the H.P. Govt. vide his letter No.Fin (c) A (3)5/2002 dated 18.12.2012 and even No. Fin (c) A (3)-13-2016 dated 22th July 2020.

In this regard, if a retiree intends to retain his/her GPF accumulations with the HPSEBL she/he may be allowed to do so with the permission of the Controlling Officers/DDO on receipts of written request from retiree to this effect and original retention application request alongwith application for final withdrawal of GPF may be sent to this office duly recommended/authenticated by the concerned controlling officer/DDO.


It is therefore, requested to all the offices of HPSEBL to direct their officers/officials who are going to be retire from HPSEBL and ~~interested~~/intends to retain their GPF accumulation with HPSEBL beyond the prescribed period of Six months, the written request should be supplied to this office through his/her DDO./Controlling Officer. In case, a retiree applies to retain his/her GPF

Accumulations with the HPSEBL directly to this office without permission of the controlling Officer/DDO in that eventuality, no interest on GPF accumulation will be given to the retiree.
