**Subject: - Deployment of one officer/official in DoE for providing regular assistance in financial, Budget & Audit matters.**

Sir,

With reference to subject cited above, it is submitted that Directorate of Energy, GoHP is the Head of Department with respect to all power utilites of MPP&Power viz. HPSEBL, HPPCL, HPPTCL, HIMURJA etc. for dealing with financial matters such as budget appropriation, CAG reports, release of sanctions & audit paras etc. These works are carried out on day to day basis and the total fund management to the tune of approximately Rs.1500 Crore annually is also being executed by this office.

In view of above, it is further submitted that this department is already having acute shortage of staff and moreover no experienced official/personnel who is well conversant with the financial matters except the Assistant Controller is working in the finance Unit of DoE due to which regular works such as reply of audit paras, compliation of audit paras, release of grant and sanctions, management of funds etc get delayed and the pendency of work keeps increasing.

It is also pertinent to mention here that most of the works as stated above which are executed at this office level pertain to HPSEBL, HPPCL, & HPPTCL. Hence, it is requested that one official each (from AAO level to Computer Operator (Accounts)) who is experienced and well conversant with above stated financial matters such as budget appropriation, CAG reports, release of sanctions & audit paras from each organization (HPSEBL, HPPTCL, HPPCL) may please be deputed in the Directorate of Energy for providing daily necessary assistance with regard to ensuring smooth and effective functioning of this office as Head of Department for financial aspect in respect of various power utilites of Department of MPP&Power, GoHP.

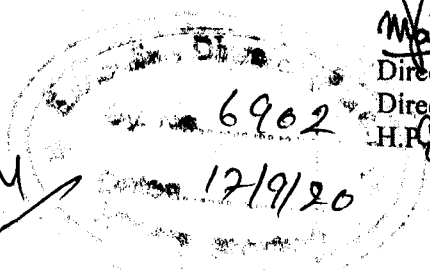
