NOTIFICATION

Whereas the State Election Commission has issued election programme vide Notification No.SEC(F)1/2019- dated 10th March, 2021 to fill up the posts of Pradhans of Development Block Totu and Chopal of District Shimla and Dharampur Block of District Mandi and up to date casual vacancies occurred in recently constituted Panchayati Raj institutions in the State,
