- 1 Regularization is being considered against the available vacancy in HPSEBL.
- 2 All the original documents/certificate. viz Bonafide/SC/ST/OBC/Educational and technical qualification etc. as prescribed in the relevant R&P Rules of Junior Engineer (E) shall be verified by the Head of Office concerned before releasing the pay of regular post.
