
Subject: - Instructions regarding maintaining reliable power supply during COVID-19 pandemic.

It is well known that the state of Himachal Pradesh is currently witnessing unprecedented surge in the number of COVID-19 cases (2nd wave). Keeping in view these exigent circumstances, various departments of the GoHP have geared up and are taking all necessary measures to combat this epidemic. Being sole distribution licensee, the task for ensuring reliable power supply throughout the State is the duty of HPSEBL. In this context, I have been directed to convey as under: -

1. Un-interrupted power Supply to designated COVID-19 institutions/laboratories, hospitals and Oxygen plants be ensured at all times. Suitable arrangements may also be made to ensure that electricity complaints in their respect are attended to on 24x7 basis.
2. Unless the situation absolutely warrants, shutdown on feeders feeding the aforesaid institutions be avoided. Cases where the shutdown is mandatorily required/un-avoidable, the activity be planned beforehand and suitable arrangements be made to ensure un-interrupted power supply to these institutions.
3. It is also to be ensured that no interruption is caused on 132kV network feeding power supply to INOX AIR at Barotiwala due to changeover of supply & similar other units in the State who are involved in manufacturing of Oxygen.






