ORDER

Whereas, in exercise of the powers, conferred under Section 10(2)(1) of the Disaster Management Act 2005, the Chairman, National Executive Committee (NEC) has directed the State Governments and State Authorities to consider to continue the containment measures for COVID-19, as conveyed vide aforesaid MoHFW advisory dated 25.04.2021.

Now therefore, in continuation of State Executive Committee (SEC) Orders dated 05.05.2021, 06.05.2021, 08.05.2021, 13.05.2021, 15.05.2021, 19.05.2021, 20.05.2021, 21.05.2021 & 24.05.2021 keeping in view the current situation of COVID-19 pandemic and fatalities across the state, the undersigned, in the capacity of the Chairman (SEC), exercising the powers conferred under section 22(2)(h) and section 24 of the Disaster Management Act, 2005 hereby directs that restrictions imposed vide aforementioned orders shall stand further extended till 6:00 AM of 7th June 2021. All restrictions and exemptions shall continue as per guidelines already issued except following additional directions which will be effective from 6:00 AM of 31st May 2021 to 6:00 AM of 7th June 2021.

1. All markets/shops can open from Monday to Friday for Five Hours (From 9AM to 2PM) but will remain closed on Saturdays & Sundays. Shops dealing with items of daily need such as fruits, vegetables, milk, milk products, Pharmacy and other essential items are however allowed to open for 5 hours on Saturday and Sunday also. The shopkeepers and buyers shall ensure compliance of COVID-19 appropriate behavior and safety protocols as per Health Department instructions.

2. All the stand alone offices with strength of up to 4 employees shall remain open with full strength and other offices of Government Departments/ PSUs/ local bodies/ Autonomous Bodies including the H.P. Secretariat will operate with 30% attendance. The Head of Departments/Head of Offices shall take the decision on actual roster as per requirement. The offices shall ensure compliance of COVID-19 appropriate behavior and safety protocols in the work place. The employees with disability, pregnant/lactating women shall however be not asked to attend offices and continue working from home. Similarly all employees not in roster shall be available for call up at short notice if required by the Head of Office. The Hon'ble High Court of Himachal

Pradesh will issue separate orders with respect to office restrictions in Hon'ble High Court and all other Judicial offices.

All educational, training, coaching institutions etc. shall continue to remain closed till further orders.

Penal provisions

Any person violating these guidelines will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005, and COVID-19 Regulations 2020, besides legal action under Sec. 188 of the IPC, HP Police Act 2007 and other legal provisions as applicable.

This Order shall remain in force, in all parts of the State for the period as aforementioned.
