"OFFICE ORDER"

In pursuance to Orders issued by the Director cum Sp. Secretary (Revenue-DM) Govt. of HP vide which order No. Rev (DMC) (C)20-2/2021-COVID-19-II dated 28th May, 2021 vide endst. No. HPSEBL (SECTT)/R&E/COVID-19/2021-12599-799 dated 29.5.2021 regarding instructions and exemptions with regard to extension of COVID curfew from 6:00 AM of 31st May,2021 to 6:00AM of 7th June, 2021 all the Officers / Officials and Personal staff working in HPSEBL are hereby directed to adhere to the following instructions in letter and spirit:

- (i) All the Branches/Officers/ cells with strength of up to 4 employees shall remain open with full strength and other Branches/Offices /Cells of HPSEBL of Board Secretariat will operate with 30% attendance.
- (ii) The Branch Officers/Head of the Personal Staff of the concerned Branches/Officers shall take the decision on actual roaster as per requirement from 31st May, 2021 onwards and communicate to their subordinates.
- (iii) The Officers/Branches shall ensure compliance of COVID-19 appropriate behavior and safety protocols in the work place.
- (iv) The employees with disability, pregnant/ Lactating women shall however be not asked to attend offices and will continue working from home.
- (v) Similarly all employees not in roaster shall be available for call up at short notice if required by the Branch Officer.
