Sir,

Kindly refer to this office letter No.HPSEBL (Sectt.)/FTE-2/321-36(Union Demand) /2021-3321-501 dated 1.6.21 on the subject cited above.

In this regard the similar instructions were issued from time to time regarding shifting of technical staff deployed in offices to their duty at field work vide letter No. HPSEBL (SECTT) /FTE-2/321-36/2018-92440-590 dated 21.3.18 (**except subjudicious of courts cases**). A period of more than three years has been elapsed and there appears to be no action taken by some your offices. Also the information in this regard were sent on what's app group by the Executive Director (Pers.) wide which some offices not furnished the Certificate / undertaking in this matter to this office. Abnormal delay in this regards has been viewed seriously by the authorities. The field technical staff is still deployed in the offices on other duties.

In view of above, this is the last & final opportunity, hence, you are therefore again requested to look into the matter personally and **Jr.T-Mate & Jr.Helpers including other technical staff who deployed in office(s) for the work of Clerical**, if any may be shifted to their duty at field work immediately as per Rules of duty defined without any delay within **5 days** of receipt of this reminder without waiting for further reminder, **otherwise disciplinary action as deemed fit as well as defiance of these order may invite departmental action against the erring officers as per Rules.** [except the Beldars(Reg)7(PP) who are performing the duty of Peon/Chowkidar etc. and those field technical staff whose case is subjudicious with Court as well as pending for personal hearing].

In addition to above, it may also kindly be ensured that after doing the needful the necessary Certificate/Undertaking to be furnished to this office within 5 days positively on the receipt of this reminder as per already proforma issued by this office. So that the Management can be apprised of the position accordingly.
