basis with HPSIDC.

R/Sir,

It is submitted that the HPSIDC requires services of a Superintending Engineer (S.E.) at Head Office Shimla on secondment basis as the post of Superintending Engineer is lying vacant. At present, there is no eligible incumbent in the feeder category who could be considered for promotion against the vacant post of Superintending Engineer and HPSIDC is also not in a position to assign the duties & responsibilities of the post of Superintending Engineer to other incumbent due to lack of adequate experience in this field, as required for the post.

It is, therefore, requested that a Superintending Engineer (S.E.) who has adequate experience in the field of Civil Construction works may be deputed from the Establishment of HPSEB with the HPSIDC on secondment basis on usual terms & conditions on an immediate basis as the on-going civil works of the Corporation are suffering due to lack of supervision at the level of Superintending Engineer.


