Division, HPSEBL, Rampur is hereby appointed as Clerk on regular basis in the Pay Band of Rs. 6400-20200+2300 Grade Pay from the date of issue of these orders or his actual taking over as such whichever is later.

The inter-se-seniority of the above official in the Grade of Clerk will be fixed later on.

The above official shall produce his original academic qualification certificate to the officer concerned before joining as Clerk.

The official having education qualification Matric 3<sup>rd</sup> Division or Matric pass in English with Hindi Rattan at the time of promotion to the post of Clerk will be promoted as Sr. Asstt. only when he will acquire the education qualification as 10+2.

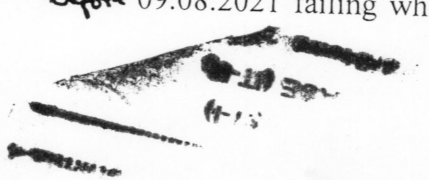
The above official shall qualify the type test i.e. 30 words per minute in English and 25 words per minute in Hindi in three chances managed by the concerned HOD's within two years from the date of joining. If he fail to qualify within the given period, one extra chance will be allowed within next one year to qualify the type test, failing which no annual increment shall be allowed to him till he qualify the requisite speed of type writing. The official appointed as Clerk it has crossed the age of 45 years can be granted exemption under the provision of F.R. 26 (17) (2).

The controlling officer is requested to obtain an undertaking from the official concerned before accepting his joining to the effect that consequent upon his appointment as Clerk as such he shall not have no claim his seniority what so ever if officials junior to him have been appointment earlier to him.

Consequent upon the appointment of above named official as Clerk is hereby here by further posted in Elect. Division, HPSEBL, Kumarsain against vacancy.

The above named official shall be entitled for usual joining time and TTA as admissible under rule.

The above named official on appointment as clerk shall join his new assignment on or before 09.08.2021 failing which his appointment orders shall deemed as cancelled without any
