**\*OFFICE ORDER\***

**Subject: - Grant of Dearness Relief to Himachal Pradesh State Electricity Board Ltd. Pensioners/Family Pension- Revised rate effective from 01.07.2021.**

In continuation to the office order No. HPSEB (SECTT(R&E/6/156/2020-87785-88030 dated 21.03.2020, the Himachal Pradesh State Electricity Board Ltd. is pleased to decide that the dearness relief payable to HPSEBL, Pensioners/Family Pensioners shall be enhanced from the existing rate of 153% to 159% w.e.f. 01.07.2021 the HPSEBL is further please to decide that dearness relief payable to pensioners/family pensioners of All India Services of Himachal Pradesh Cadre who are drawing their revised pension on the basis of 7<sup>th</sup> Central Pay Commission report shall be enhanced from present rate of 17% to 23% w. e .f. 01.07.2021.

1. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off the next higher rupee.
2. Other Provisions governing grant of Dearness Relief to pensioners such as regulation of Dearness Relief during employment/-re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.
3. These orders shall apply to all the pensioners/Family Pensioners of the HPSEB Ltd.
4. As Dearness Relief is at a uniform rate, it has been decided to dispense with the issue of enclosing ready reckoner along with these orders. It will be the responsibility of the pension disbursing authority, including the Nationalized Banks, etc. to calculate the quantum of dearness relief payable in each individual case.
5. The Chief Accounts Officer, Drawing & disbursing Officer & the authorized Public Sector Banks are requested to arrange payment of Dearness Relief to pensioners on the basis of these orders.


