The Aims and Objectives (Terms of Reference) of the Prashar Development Authority shall be as under:-

- i) To protect and preserve the Prashar Lake.
- ii) To protect and preserve the Prashar Temple.
- iii) To protect and preserve the physical/ecological environment around the Prashar Lake.
- iv) To promote tourism traffic to the Lake and to provide amenities like Rest House, Roads, Tracks etc., to the pilgrims and tourists travelling to the Lake.
- v) To protect and renovate other temples falling within the territorial jurisdiction of Prashar Devta.
- vi) To oversee the collection made at the Prashar Temple from devotees and to devise ways and means of spending such collections.
- vii) To oversee the organization of fairs etc., associate with the resources and income of the authority and to frame appropriate schemes for the expenditure of income earned/collected.
- viii) To protect, preserve and promote the historical, social and religious traditions associated with the Prashar Lake and Temple.

In addition to the above authority will undertake any further development work in the area entrusted by the Government in this behalf.

The authority is constituted for a period of two years. The Non-Official members will get TA/DA in accordance with the existing rules/instructions of the Government as amended from time to time.
