ORDER

WHEREAS the applicant Er. Bhupinder Singh, Assistant Engineer (Elect.) working in RE, Bhaba Power House Division, Bhabanagar has filed a CWP No.6297 of 2021 with the plea that he may be transfer from tribal area to his choice of station.


AND WHEREAS the aforesaid C.W.P came up for hearing before the Hon'ble High Court on 4.10.2021 and the Hon'ble High Court passed the direction/order as :

1. The petitioner has admittedly completed more than five years of service in Tribal area having been posted there as Assistant Engineer (Electrical), therefore, he has entitled to be transferred to a soft station in terms of Comprehensive Guiding Principles-2013 for regulating the transfer of State Government employees which has been adopted by the respondents-Board
2. The instant petition is disposed of with a direction to the respondents to consider, decide and then issue consequential orders of transfer of the petitioner to any of the four stations as mentioned in prayer clause of this petition, which reads as under: i) O/o Resident Engineer Binwa Power House Division, HPSEBL, Binwa, ii) Assistant Engineer Elect. Mtc Sub-Division, HPSEBL Jia, iii) O/o Superintending Engineer (Design), PHE, HPSEBL, Sundernagar iv) Electrical Sub-Division, HPSEBL Nurpur.
3. It is made clear that the respondent shall not insist upon the joining of the substitute, before relieving the petitioner. For compliance to come up on 01.11.2021.
