### ORDER

**WHEREAS** Er. Ram Pal, Assistant Engineer (Elect.) presently working in Elect. Sub-Divn., HPSEBL Kandror under Elect. Divn., Ghumarwin has been transferred to O/O SE (D) ES Hamirpur vice Er. Ravinder Kumar, AE (E) vide office order No. 111 dated 15.6.2021 whereby being aggrieved with above orders, he filed CWP No. 3389/2021 titled as Ram Pal V/s HPSEB Ltd. in the Hon'ble High Court at Shimla and prayed that his transfer order dated 15.6.2021 may be quashed and set aside.

**AND WHEREAS** the aforesaid C.W.P came up for hearing before the Hon'ble High Court on 21.10.2021 and the Hon'ble High Court passed the direction/orders as :


1. "This writ petition has been challenging the order of transfer order 15<sup>th</sup> June, 2021 (Annexure-P-3) by which the petitioner, even before completing the tenure of three years, was transferred from Elect. Sub-Divn., Kandror to the office of SE (O) ES Hamirpur vice respondents No.2.
2. This Court, on 18.6.2021, while issuing the notice of the writ petition to the respondents, stayed the operation of the impugned order dated 15.6.2021. The said order is operative till date.
3. The learned Counsel for the petitioner argued that the petitioner is likely to complete the tenure of three years in the next month and respondent No.2 has been accommodate at the instance of one MLA even he had served only for a period of 10 months at the place of his earlier posting at Hamirpur.
4. "Having regard to the submissions on the merits of the case, we dispose of this writ petition directing respondent No.1 to pass fresh order of transfer in respect of both the petitioner and respondent No. 2 to any other station other than the disputed one, within a period of one month from today.
5. The interim order dated 18.6.2021 shall remain operative, for a period of one month from today. However, if respondent No. 2 has been working during the intervening period has salary and other emoluments shall also be released to his within the aforesaid period.
