The inter-se-seniority of the above named officials in the grade of Foreman (Line) shall be fixed later on.

The controlling officers shall verify the name, exact date of birth and Academic/ Technical qualification, eligibility criteria as required under the Rule before allowing the promotee to join as Foreman (Line).
