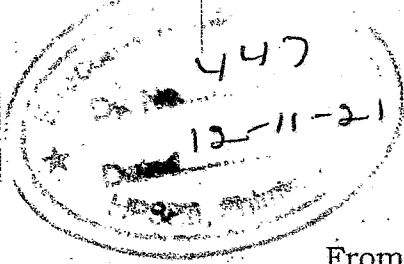
2. In this context, it is intimated that one of the basis on which the Petitioner has filed the CWP No.4079/2020 is that Recruitment and Promotion Rules and other relevant information are not being uploaded on the official websites of State Government Departments/Boards/Corporations etc.

3. The Hon'ble Court has observed that when the relevant Rules and Regulations are not available on the official website, the very purpose of computerization and uploading of the Rules and other relevant information on the official websites of the Boards, Corporations as also the State is not only defeated, but even this has led in unnecessary litigation, clogging the docket of this Court. 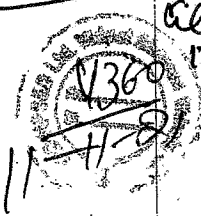


