RECRUITMENT & PROMOTION REGULATIONS FOR THE POST OF STOCK  
VERIFICATION OFFICER IN HPSEB (STATE CADRE).

1. Name of post: Stock Verification Officer.
2. Nos. of Posts: (One) or as determined by the Board from time to time.
3. Pay Scale: Rs. 2200-4000
4. Classification: Class - II
5. Whether Selection or Non-Selection: Selection.
6. Age limit for direct recruits: Not applicable.
7. Education and other qualification required for direct recruitment: Not applicable.
8. Whether age and educational qualifications prescribed for direct recruits will apply in the case of promotions: Not applicable.
9. Period of probation, if any: Two years subject to such further extension (not exceeding one year) as may be ordered by the competent authority in special circumstances and reasons to be recorded in writing.
10. Method of recruitment, whether by direct recruits/ promotion/by deputation or percentage of vacancies to be filled-in by various methods: By promotion.
11. In case of recruitment by promotion, deputation, transfer, grades from which promotion/deputation/transfer to be made: By promotion from amongst Stock Verifiers having minimum 10 years regular service and having minimum qualification as graduate in the grade.
12. Composition of DPC/ Selection Committee: As may be constituted by the Board from time to time.
13. Appointing Authority: Board.
14. Relaxation of Regulations: In the matter of granting relaxation in qualification/experience and length of service, the competent authority shall be the Board.
