Promotion from the Superintending Engineers (Elect.) holding recognized degree in Electrical Engineering / Electrical & Electronic Engineering/Computer Science Engineering/ Electronic & Communication Engineering & Information Technology with combined regular/adhoc service of 20 years as AE/AEE/Sr. Xen / Addl. SE and SE/ Dy. C.E. (Elect.) out of which minimum 2 years should be as S.E.
