In pursuance of the instruction contained by the HP Government vide letter No. PER (AP)-C-B (2)-1/2019 dated 28th December, 2021 issued by the Under Secretary (Pers.) to the Government of HP further notification of HPSEBL (Sectt)/R&E/Govt. Instt. Contract/2021-680-900 dated 01.04.2021 read with Executive Director (Pers.) letter No. HPSEBL (Sectt.)/FTE-2/321-36/2019-65671-851 dated 03.01.2022 and on the recommendations of the Departmental Screening Committee, the services of the following Field Technical Staff (i.e. Junior Helper (Sub-Station)) who have completed minimum two years un-interrupted contractual service on or before 30.09.2021 are hereby regularized w.e.f. 01.10.2021 with deemed date i.e. 01.01.2022 in their respective offices / sections in the initial Pay scale plus allowances as admissible under Rules from time to time in HPSEBL on the terms and conditions mentioned below:

Their regularization to the above post (s) is further subject to the following terms and conditions:

1. That contractual appointees will be eligible for regularization against availability of vacancy.
2. The regularization will be strictly on the basis of seniority subject to the condition that eligibility criteria etc. Prescribed in the Recruitment and Promotional Rules for the post have been observed at the time of their initial recruitment on contract.
3. The candidate should be medically fit for the post against which he / she is being considered for regularization. Obtaining the medical fitness certificate of the candidate shall be ensured in accordance with the provisions contained in FR 10 and SR 4 (1), 4 (2) and 4 (3).
4. The regularization shall be subject to verification of character and antecedents of the candidate being considered for regularization as provided in the H.P. Financial Rules.
5. For the determination of date of birth of the candidate concerned, the criteria as laid down in Rule, 1972 of the Himachal Pradesh Financial Rules, 2009 shall be observed.
6. A Screening Committee shall be constituted in the department concerned for regularization.
7. The contractual appointees who are to be regularized shall be appointed at the minimum of time scale of the post.
8. The contractual appointees who are regularized shall be liable to be posted anywhere in the state. In the interest of Board's Ltd. Work by retaining their seniority in the present Division.
9. That, regularization will be with prospective effect i.e. from the date of issue of regularization orders with the deemed date as prescribed.
10. That, they will be governed by Group Saving Linked Insurance Corporation of India as introduced in the Board Ltd.
