


Sir/Madam,

I am directed to invite your attention towards this department letter of even number dated 2.8.2021 on the subject cited above and to say that the Registrar General & Census Commissioner, Ministry of Home Affairs, GOI vide his letter No. 9/33/2019-CD(CEN), dated 23.12.2021 has informed that owing to the prevailing conditions due to new variant Omicron of COVID-19 pandemic and the States/UTs being pre-occupied in the vaccination drive against COVID-19 in the country and postponement of Census work until further orders, it has been decided to further extend the date of freezing of boundaries of administrative units upto 30.06.2022 for the ensuing Census. Therefore, any changes made to the administrative boundaries should be notified latest by 30.06.2022 and the copies of notifications on jurisdictional changes are to be sent to the Directorate of Census Operations, Shimla with endorsement to the Office of Registrar General & Census Commissioner, GOI.

You are, therefore, requested to kindly bring it to the notice of all concerned under your control for compliance.
