"OFFICE ORDER"

WHEREAS, Shri Kalyan Singh, Assistant Engineer, (C/M.) was repatriated/ transferred from the HPPTCL to O/O the Chief Engineer (MM) vide office order 13 dated 31.1.2023 endst. No HPSEBL (SECTT)/GE 102-34/2022-10336-45 dated 31.1.2023 and being aggrieved with the transfer order had filed CWP No. 532/2023 in the Hon'ble High Court Himachal Pradesh at Shimla.

AND WHEREAS, the aforesaid CWP aforesaid came up for hearing before the Hon'ble High Court H.P at Shimla on 8.2.2023 when the Hon'ble Court has pleased to dispose of the said CWP with following directions:-

- "Accordingly, without adverting to the merits of the case, this writ petition is disposed of with liberty to the petitioner to approach the respondent by way of fresh representation in terms of the transfer policy, dated 10th July, 2013, within a week from today. In case, the petitioner moves the said presentation within one week, the respondents shall decide the same, in accordance with Law, within a period of two weeks thereafter. Till the disposal of the representation moved by the petitioner, the operation of the impugned order, Annexure P-9, dated 2.2.2023, shall remain stayed. "

AND WHEREAS in compliance to above directions of Hon'ble High Court the said Sh. Kalyan Singh, Assistant Engineer submitted a representation praying therein that he may be adjusted in any of the five (5) stations of his choice which are as under:-

1. RE, Gaj P/H HPSEBL, Garoh
2. RE, Khauli P/House, Shahpur
3. SE(OP) Circle HPSEBL, Kangra
4. SE(OP) Circle Dalhousie

AND WHEREAS the competent authority has considered on the representation dated 2.2.2023 put in by the Applicant and taking a sympathetic view the petitioner has been ordered to be adjusted in the O/O SE (Op.) Circle HPSEBL Dalhousie against vacancy.

NOW THEREFORE, taking into consideration all relevant facts and circumstances of the case, the impugned transfer order dated 31.1.2023 endst. No HPSEBL (SECTT)/GE 102-34/2023-10336-45 dated 31.1.2023 is hereby amended and Er. Kalyan Singh, Assistant Engineer(C/M) is hereby adjusted in O/O SE (Op.) Circle HPSEBL Dalhousie against vacancy with immediate effect.

The representation dated 2.2.2023 of the Petitioner shall stand disposed of accordingly.
