ORDER

WHEREAS the applicant Er. Yashan Bhardwaj, Assistant Engineer (Elect.) working in Elect. Sub-Divn., Kaza has filed a CWP No.1521 of 2023 with the plea that he may be transferred from tribal area to his choice of station.


AND WHEREAS the aforesaid C.W.P came up for hearing before the Hon'ble High Court HP Shimla on 29.3.2023 and the Hon'ble High Court passed the direction/order as :

1. "Thaat the respondent may very kindly be directed to consider the request of petitioner for transfer from the present place of posting to the station of his choice as mentioned in para 9 of the CWP keeping in view of the transfer policy"
2. The petitioner has completed his normal tenure of service in the tribal area and is thus entitled to be posted to one of the soft stations of his choice. The petitioner has opted the following stations of his choice in para-9 of the petition which are as follows:

1. Elect. Sub-Divn., Shahtlai.
2. Elect. Sub-Divn., Bagana.
3. Elect. Sub-Divn., Barsar.
4. Elect., Sub_divn., Ghumarwin.
5. Elect. Sub-Divn., Galore.

3. In the given facts and circumstances of the case, we deem it appropriate to disposed of this petition by directing the respondents to consider and decide the case of the petitioner and thereafter consequential orders of transfere be issued to anyone of the aforesaid soft stations of his choice, within a period of four weeks from today. Order accordingly.
4. Pending application, if any, also stand disposed.

Now therefore, keeping in view of Hon'ble High Court order dated 29.3.2023 and after considering the facts and circumstances of the case, Er. Yashan Bhardwaj, Assistant Engineer (Elect.) is hereby adjusted in Elect. Sub-Divn., Shahtlai under Elect. Divn., Ghumarwin against vacancy with immediate effect .
