In pursuance to the Under Secretary (Personnel) to the Government of Himachal Pradesh office letter No. PER (AP)C-B(2)-1/2014-V.II dated 30.04.2023 and further adopted by the HPSEB Ltd., vide his Office Order No. HPSEBL (Sectt.)/ R & E/ Govt. Inst. Contract/2023-24-7812-8032 dated 01.05.2023 the services of **Ms. Chetna, (D.O.B. 08.01.2002) Junior Office Assistant (IT)** appointed under Employment Assistant Scheme Vide Memo No. 83511-19 dated 24.03.2021 presently working in Elect. - The seniority of the above-mentioned official will be fixed in the respective cadre later on. However, the entitlement of leave(s) etc. under CCS (Leave) Rules shall accrue to the officials from the date of issue of these orders.
- Her appointment will be subject to the production of Medical Certificate of fitness from the Medical Officer of the Govt. Hospital.
- The contractual appointee who are regularized shall be liable to be posted anywhere in the State.
- Necessary entry to this effect is required to be recorded in the service book of concerned officials.
