It is rather shocking that while implementing the judgment of this Court, the respondent, who is younger in age has been accommodated at Bhabanagar, which though is described as a tribal area is adjoining to non-tribal area and is at a stone throw distance from Rampur. Whereas the petitioner, who is elder in age has been ordered to be posted at tribal area of Kaza. Obviously this point has generated a lot of heart-burning.

Accordingly, respondent No.1 is directed to transfer and post the private respondent in an equally tribal area stricto sensu. In case, there is no vacancy, respondent No.1 shall create such vacancy by transferring the oldest incumbent manning such position. The entire exercise shall be completed within one week.
