

All the aforesaid officers in whose case change of station is involved will be entitled to usual TTA/Joining time as admissible under the rules.



Incase at any stage the post(s) of Sr.XEN(E) becomes excess due to repatriation in the HPSEBL or any reason, the junior(s) most will be reverted back. In case of deputation/secondment made on the requisition of other organization/ Deptt. of GoHP then:-

The contribution towards Leave salary, Pension and Gratuity etc. in respect those employees who have been posted on secondment/ deputation basis shall be made by the Borrowing Department in terms of this office order endorsement No.HPSEBL/Sectt./R&E/154-1/2011-116083-125 dated 28-01-2012 , even No.137722-72 dated 20-03-12 and No. HPSEBL (SECTT) Dep./103-5/2013-102787-862 dated 8.3.2013. In case of refusal of the same by the borrowing Department the individual employee concerned shall contribute the same himself. In case of non-receipt of the same from the Borrowing Department or from the individual employee concerned, he/ they will not be entitled to pension and other retiral benefits for the period of deputation/secondment from the HPSEB Limited.
