You are therefore, once again requested to deploy interested officers/officials to fill up the following categories of posts on secondment basis in this Authority at the earliest:-

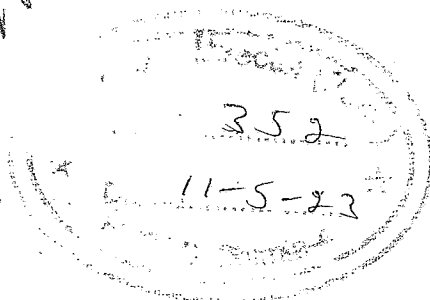
