Subject:- Posting of Supdt. (Accounts) / Accounts Officer in HPSLDC, GoHP, Totu, Shimla.

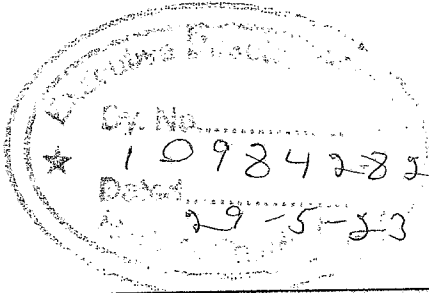
Sir,

HPSLDC is an apex body to ensure integrated operation of power in the Himachal Pradesh and responsible for optimum scheduling, Monitoring, Accounting, Settlement of transaction of Electricity. In order to perform the duties of Accounts in HPSLDC, this office has only one Assistant Accounts officer deputed by HPSEBL on secondment basis. Due to shortage of manpower in Accounts Unit of HPSLDC, this office has requested vide UO Note No. HPSLDC-1/2022/9251 dated 01.01.2023 to post a Supdt. (Accounts), Shri Kuldeep Kumar, who was willing to serve in HPSLDC, however, till date, HPSEBL has not posted / deputed any Supdt. (Accounts) in this office. It is intimated that this office is facing difficulty to maintain the accounts of HPSLDC, due to which Accounting works of this office is suffering badly, and resulting loss to HP State.

In view of above, it is therefore, requested that Supdt (Accounts) or Accounts Officer, who is willing to serve in HPSLDC for minimum two years on secondment, may be posted in HPSLDC, at the earliest, so that works of HPSLDC may not suffer.
