Sr. No.2. shall join his new assignment within 10 days from the date of issue of the orders, falling which his promotion orders shall be deemed as withdrawn without any further notice and the next officer in the seniority shall be offered the promotion/posting orders.

The controlling officers shall ensure that the officers are relieved immediately unless the officers' voluntary forgo(s) the promotion and gives the request to this effect in writing which may be forwarded to this office without any delay.

In case at any stage the post(s) of Sr. Executive Engineer(C/M) becomes excess due to repatriation or any other reason in the HPSEBL, the junior most incumbent(s) shall be reverted. The officers in whose case change of station is involved will be entitled to usual TTA & joining time as admissible under rules & **no extension in joining time will be granted.**

In case of deputation/secondment made on the requisition of other organization/ Deptt. of GoHP. then:-

The contribution towards Leave salary, Pension and Gratuity etc. in respect those employees who have been posted on secondment/ deputation basis shall be made by the Borrowing Department in terms of this office order endorsement No.HPSEBL/Sectt./R&E/154-1/2011-116083-125 dated 28-01-2012 , even No.137722-72 dated 20-03-12 and No. HPSEBL (SECTT) Dep./103-5/2013-102787-862 dated 8.3.2013. In case of refusal of the same by the borrowing Department the individual employee concerned shall contribute the same himself. In case of non-receipt of the same from the Borrowing Department or from the individual employee concerned, he/ they will not be entitled to pension and other retiral benefits for the period of deputation/secondment from the HPSEB Limited.
