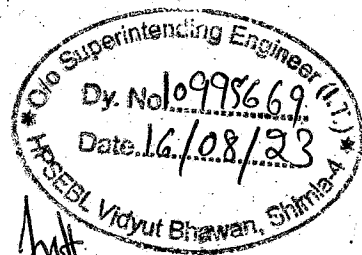
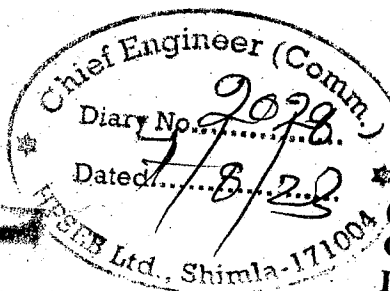

Sir,

In the subject cited matter, it is intimated that the above mentioned writ
petition was listed before the Hon'ble High Court on 22.06.2023 when the Hon'ble Court has
passed the following order:-

CMP No.9915 of 2022 and CWP No. 5945 of 2021. Heard.
Going by the conduct of the petitioner, whereby majority of the
works, as awarded to him, have not been started and, if started,
have not been completed, we deem it appropriate to vacate the
interim order dated 24.09.2021. Ordered accordingly. The
application stands disposed of.

2. However, that does not mean that the petitioner will get away
lightly by not completing those of the works. The petitioner is
directed to file an affidavit clearly setting out therein the
timeline within which he would complete the works in question,
which either have not been started or, if started, are in the mid-
way, but have not been awarded to any other contractor thus
far. It is also directed that not only the respondents herein, but
any other department of the State Government, Board or
Corporation etc., as the case may be, would not release any
amount in favour of the petitioner herein without the express
leave of the Court.

3. A copy of this order be sent to the Chief Secretary to the
Government of Himachal Pradesh, Engineer-in-Chief, HPPWD
and Engineer-in-Chief, I & PII.

4. In the meanwhile, the Principal Secretary, HPPWD, is directed to initiate action against the erring official/officer(s) on account of whose negligence, despite the petitioner having defaulted, either in not commencing the works or stopping the same in the mid-way, no action was taken against him and rather they continued to award fresh works to him.

5. We are informed at the Bar that the petitioner has been awarded as many as 66 contracts/works. The Principal Secretary, HPPWD, shall take into consideration the status of these 66 works and any other works that may have been awarded to the petitioner.

6. List on 13.07.2023 on which date fresh status report be filed by the respondents.

CWP No. 962 of 2023.

7. Since, the interim order has been vacated in CMP No.9915 of 2022 in CWP No. 5945 of 2021, therefore, the respondents are at liberty to open the financial bid submitted by the petitioner and take consequential action, if any, required.

8. Accordingly, the Civil Writ Petition No. 962 of 2023 is disposed of in the aforesaid terms, so also the pending application(s), if any.

You are therefore, requested to comply with the order dated 22.06.2023 passed by the Hon'ble High Court by not releasing the amount in favour of the petitioner without the express leave of the Court.

Any laxity in this matter shall be your own personal responsibility.
