ORDER

WHEREAS Sh. Yashwant Singh, Sr.Assistant was transferred from Bhaba Power House Division, HPSEBL, Bhabanagar to Elect. Division, HPSEBL, Gagret vide office order No.2 dated 01.04.2023 and relieved of his duties on 19.05.2023.

AND WHEREAS the applicant did not join at Elect. Division, HPSEBL, Gagret and adjusted in Elect. System Division, HPSEBL, Reckong-Peo at Bhabanagar vide office order No.100 dated 07.06.2023.

AND WHEREAS the applicant again transferred from Elect. System Division, HPSEBL Reckong-Peo at Bhabanagar to Elect. Division, HPSEBL Gagret vide office order No. 163 dated 26.07.2023 on administrative grounds. Feeling aggrieved with this, he had filed CWP No.4927 of 2023 titled as Yashwant Singh Vs. HPSEBL & another in the Hon'ble High Court of H.P at Shimla which was listed in the Hon'ble High Court of H.P on 03.08.2023 and the Hon'ble Court has passed following order/judgment:-

“Heard.

2. The petitioner's grievance is against order dated 26.07.2023 (Annexure P-4), whereby, he has been transferred from Elect. System Division, HPSEBL Reckong Peo at Bhabanagar to Elect. Division, HPSEBL Gagret.

3. The pleaded case of the parties is that:-

3(i) the petitioner was appointed initially as Peon. He was posted as such at Reckong Peo, District Kinnaur w.e.f. 13.05.2003 to 14.03.2007. He was promoted as Clerk on 15.03.2007 and again



remained posted as such at Reckong Peo till 13.03.2023. In between, he was promoted as Sr. Assistant on 14.09.2010.

3(ii) He was transferred outside Reckong Peo for the first time on 01.04.2023. This transfer was on the basis of a D.O. note. The petitioner was ordered to be transferred to Electrical Division HPSEBL Gagret.

3(iii). In terms of instruction memo dated 02.08.2023, placed on record by the respondents, petitioner did not comply with the transfer order dated 01.04.2023 and remained posted at Bhabanagar (Reckong Peo). He was adjusted under order dated 07.06.2023 again at Bhabanagar (Reckong Peo).

3(iv). According to the respondents, taking into consideration long incumbency of the petitioner at Bhabanagar (Reckong Peo), he was transferred vide order dated 26.07.2023 to Electrical Division HPSEBL Gagret, District Una.

4. Learned senior counsel for the petitioner does not dispute that the petitioner has long incumbency at Bhabanagar (Reckong Peo) and that he has never served any station other than Bhabanagar (Reckong Peo). It is however, submitted for the petitioner that since he has served in tribal area, therefore, he should be posted at a station of his choice in accordance with the applicable transfer policy. Learned counsel for the petitioner further submits that the petitioner is willing to make a representation in that regard to respondent No.1, whereafter, respondent No.1/competent authority be directed to decide the same within a time bound schedule. Learned counsel for the respondents is not averse to the suggestion.


5. In view of above submissions, this writ petition is disposed of by permitting the petitioner to make a representation to respondent No.1/competent authority within three days from today, which shall be considered and decided by respondent No.1 /competent authority in accordance with law and applicable policy, within a period of one week. Thereafter, the decision so arrived at shall

also be communicated to the petitioner. Learned counsel for the respondent assures the decision of the representation within the time-line indicated above. The pending miscellaneous application(s), if any, also stand disposed of”.

AND WHEREAS in pursuance to the order/judgment dated 03.08.2023 passed by the Hon'ble Court, the applicant has sent his representation wherein he has given his choice of stations i.e. Jeori (Kotla), Distt. Shimla, Rampur, Distt. Shimla and Karsog.

NOW THEREFORE taking into consideration all the facts and circumstances of the case, Sh. Yashwant Singh, Sr. Assistant who is under orders of transfer from Elect. System Division, HPSEBL, Reckong-Peoo at Bhabanagar to Elect. Division, HPSEBL, Gagret is hereby adjusted in Elect. Division, HPSEBL Karsog against vacancy. He shall not be entitled to any TTA/Joining time.

The representation of the Applicant is disposed of accordingly.


