“ORDER”

WHEREAS Smt. Anuradha, Junior Office Assistant (IT) presently working in Elect. Sub-Division, HPSEBL, Barot under Elect. Division Jogindernagar had filed CWP No. 4678/2023 titled as Anuradha Vs HPSEBL, in Hon'ble High Court of H.P. at Shimla which was listed in Hon'ble High Court of H.P. on 21.07.2023 and the Hon'ble Court has passed following order/ judgment:-

Issue notice to the respondents. Mr. Vikas Chaudhary learned standing counsel appears and waives service of notice on behalf of the respondent.


2. Petitioner is seeking his transfer from his present place of posting at Electrical Sub- Division, Barot (Chuhar Ghatti) stated to be difficult sub-cadre area. According to the petitioner, he has completed his normal tenure at this difficult sub-cadre area and is entitled to be transferred to a soft area. The grievance of the petitioner is that his representation in that regard has not been adjudicated by the respondents.
3. Taking note of the submission advanced by the learned counsel for the parties, this petition is disposed of by permitting the petitioners to make a fresh representation seeking his transfer in accordance with applicable policy, to respondent No.1 within a week from today, which shall be considered and decided by respondent No.1/ competent authority in accordance with law and applicable policy, within a period of three weeks thereafter. The decision so arrived at shall also be communicated to the petitioner.
4. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application (s), if any.
