The above official on promotion shall join the new assignment at the places of posting as above on or before 28.09.2023, failing their promotion orders shall be rescinded and next official in the select panel shall be promoted. The controlling officer shall ensure that this official is relieved immediately to enable them to join at the new place of his posting on promotion. His relieving should not be delayed on any pretext unless the official voluntarily forego the promotion and give the request to this effect in writing which may be forwarded to this office without any delay to take necessary action to withdraw the promotional increments granted to him then on completion of 23 years of service.

ii) The Controlling Officer before relieving the above named officials shall ensure that no vigilance case is pending/ being contemplated against the officials, if so the matter be reported to this office and the official may not be relieved.
