In case of deputation/secondment made on the requisition of other organization/ Deptt. of GoHP then:-

The contribution towards Leave salary, Pension and Gratuity etc. in respect those employees who have been posted on secondment/ deputation basis shall be made by the Borrowing Department in terms of this office order endorsement No.HPSEBL/Seckt./R&E/154-1/2011-116083-125 dated 28-01-2012, even No.137722-72 dated 20-03-12 and No. HPSEBL (SECTT) Dep./103-5/2013-102787-862 dated 8.3.2013. In case of refusal of the same by the borrowing Department the individual employee concerned shall contribute the same himself. In case of non-receipt of the same from the Borrowing Department or from the individual employee concerned, he/ they will not be entitled to pension and other retiral benefits for the period of deputation/secondment from the HPSEB Limited..
