For the proper and expedient implementation of the Tribal Area Development Programme(TADP) for the development of Tribal Areas of Himachal Pradesh, the Governor, Himachal Pradesh is pleased to make the following amendment in the Himachal Pradesh Nucleus Budget for Tribal Areas Rules, 1995 by substituting the clause(iii) of Rule 5 of said Rules as follows:

Rule 5(iii) for any particular sanctioned scheme, the maximum limit of expenditure from the Nucleus Budget would be Rs. 3,00,000/- subject to the condition that the scheme in question benefits at least five different families or serves community purpose and is not for any particular individual's benefit.

This issues with the prior concurrence of the Finance Department obtained vide their U.O. Note No. 55887029, Fin(C)-B(15)-14//2016-L dated 19-05-2023.






