As you are aware, Jute is a natural, renewable and eco-friendly fibre abundantly produced in India. A range of Jute Diversified Products are made from jute fibre and widely used almost all over the world.

2. Among these, Jute Geotextiles, a fabric either woven, non-woven, has emerged as a natural, sustainable and effective solution in many areas like (i) erosion control of soil, (ii) stabilization of earthen or hill slopes, (iii) construction of roads including haul roads, (iv) erosion control of river bank, and (v) control of railway track subsidence including embankment, apart from its use in Agri-horticulture and forestry etc.

3. These products have been standardized by Bureau of Indian Standards and also included in the Schedule of Rates by some State Governments such as West Bengal, Assam & Meghalaya.
