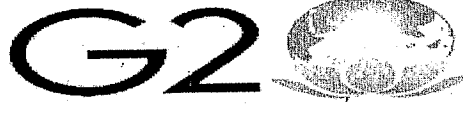

The above named official will not be entitled to TTA/Joining Time.

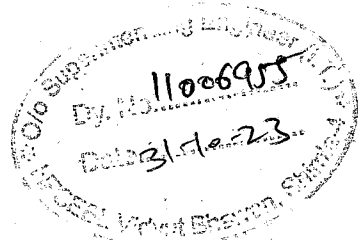
