orders and the entire record of all running / pending cases of HPSEB Ltd. shall be handed over to the newly appointed SC-Cum-LA's immediately.


The field officers may ensure equal distribution of work amongst the SC-Cum-LAs where more than one SC-cum-LAs have been appointed for the same Court.
