### ORDER

**WHEREAS**, Er. Harinder Kumar, Superintending Engineer (Electrical) was imposed a penalty of withholding of his future increments of pay for a period of three years with cumulative effect from 22.09.2022 vide order No. HPSEBL (SECTT) V&I/8-2597/2022-797-806 dated 22.9.2022.
