NOTIFICATION

The Governor Himachal Pradesh is pleased to notify the scheme for rescue and rehabilitation of the Children in Street Situation (Ciss) namely "Mukhya Mantri Asahay Baal Punarvas Niti" as per Annexure-A with immediate effect in the following manner:-

1. Aim and Objectives:-

- I. Effective implementation of SOP 2.0 formulated by the National Commission for Protection of Child Rights, New Delhi for care and protection of Children in Street Situations.
- II. To take steps for identification and suitable rehabilitation of children in street situations.
- III. To provide for roles and responsibilities of the nodal officer at both State level and District Level for rehabilitation of children in street situations.
- IV. To recommend measures for rehabilitation of children in street situations in accordance to their prevailing situation and provide for a plan for reporting and monitoring of children in street situations.

2. Coverage:-

Categories defined under 3.1 & 3.2 in the scheme shall be covered under the scheme. All such children shall be produced before the concerned Child Welfare Committee by District Child Protection unit, voluntary organization, Government officials, Child Line, Police, Labour Department Education Department and concerned agencies working in field of child sector or any person. The Child Welfare Committee shall enquire the matter and take necessary action as per SOP 2.0 and report the case to the concerned Deputy Commissioners/ Magistrates, who shall review the process of identification and rescue of CISS. The Deputy Commissioner/ Magistrate may pass order for providing of one time financial assistance of Rs. 2000 to the child in street situation from the Juvenile Justice Fund in two installments subject to enrollment and retention of the child in the school.

Rate of Grant:-

The expenditure of Rs.2000/- one time financial assistance as immediate relief shall be provided to the identified street children on the order issued by the Deputy Commissioner/ District Magistrate from Juvenile Justice Fund. One time financial assistance of Rs. 2000/- to the street child is given in two installments subject to enrolment and retention of the child in the school. 1st installment of Rs. 1000 be given immediately as soon as the child is enrolled in the school and the 2nd installment given after confirming the fact that the child has been retained in the school for next 6 months. Both the installments are proposed to be given on production of the certificate issued by the head of the concerned school, where the child has been admitted.

4. Power of Sanction:-

Deputy Commissioner/ District Magistrate shall be competent to sanction Rs.2000/- one time financial assistance as immediate relief to the identified street children.

5. Drawing & Disbursement of grant:-

The grant will be drawn and disbursed by the District Programme Officer to the District Child Protection Officer, who shall further disburse it to the beneficiaries. The District Child Protection Officer will maintain separate record for the scheme and Audit of Accounts of expenditure shall be conducted like other schemes under the District Child Protection Officer. The money will be transferred into the bank account of the concerned applicant.

6. Verification:-

Deputy Commissioner/ District Magistrate/District Child Protection Officer/ Child Welfare Committee shall verify that the identified child comes under the category i.e. Children in Street situation and that he/ she has not been benefited under any other similar departmental scheme for grant. The concerned officer/official shall also verify that the child is regularly going to school & obtain the attendance from the Head/Principal of the school and the amount has been properly utilized for the purpose for which it has been sanctioned.

7. Terms and Conditions:-

1) Identified street child shall be produced before the Child Welfare Committee by District Child Protection unit, voluntary organization, government officials and concerned agencies working in field of child sector or any person and verify the facts as Under:-

- i. Proof of date of birth of child issued by the competent authority. (The child should not be above the age of 18 years)
- ii. Aadhaar card of child and parents/guardians.
- iii. Copy of bank account pass book of the applicant depicting Bank Name, Branch, IFSC Code & Account Number.

2) Child Welfare Committee shall report the case to the concerned Deputy Commissioner/ Magistrate.

3) Deputy Commissioner/ Magistrate pass the order to provide one time financial assistance of Rs. 2000/-.

4) Proof of admission in the school.

5) Attendance of child after 6 months of the admission duly signed by the Head/Principal of the school for allotting second installment.

6) After receiving the grant, if child again found in streets FIR shall lodged against the parents/guardians of the child.


