In pursuance to the Deputy Secretary (Personnel) to the Government of Himachal Pradesh office letter No. PER (AP) C-B (2) -2/2015- dated 02.12.2023 and further adopted by the HPSEBL vide letter No. HPSEBL (SECTT) R&E / Govt.Instt. Contract /2023 - 8009-8259 dated 06.06.2024 the services of Sh. Sunil Kumar, (D.O.B. 27.09.1978) Supdt. (D/A) appointed under PWD Blind Person only Low Vision Vide Memo No. 50548-55 dated 09.11.2021 presently working in Elect. Division, HPSEBL, Mandi who have completed two years continuous service as on 31.03.2023 is hereby regularized from prospective effect i.e. from the date of issue of order in the initial Pay Matrix fixed (45600-1,44,300/-) Level-14 as notified by the Notification No. 01 dated 12.04.2022. The regularization may be made after observing all codal formalities, subject to the terms and condition as mentioned in the order dated 02.12.2023.

Terms and condition is as under:-

- All the Head of Office/DDOs concerned to verify the original certificates of the official viz Himachali, Academic, Technical Qualification, SC/ST/OBC/ ESM/ Disability and all others relevant at the time of their joining on regular basis.
- The Character & Antecedent Report of above named official is to be got verified from the concerned competent authority within the period as required under rules.
- The seniority of the above-mentioned official will be fixed in the respective cadre later on. However, the entitlement of leave(s) etc. under CCS (Leave) Rules shall accrue to the official from the date of issue of this order.
- His appointment will be subject to the production of Medical Certificate of fitness from the Medical Officer of the Govt. Hospital.
- The contractual appointee who are regularized shall be liable to be posted anywhere in the State.
- Necessary entry to this effect is required to be recorded in the service book of concerned officials.
